Subject: Allocation of trainees under Upgrading the Skills and Training in Traditional Arts/Crafts for Development (USTTAD) scheme for the year 2016-17.

Sir,

I am directed to say that based on meeting/presentation made before the Inter-Ministerial Screening Committee under the scheme of **Upgrading the Skills and Training in Traditional Arts/Crafts for Development (USTTAD)**, Shri Krishna Gramottan Samiti has been empanelled as a Project Implementing Agency (PIA) under the scheme from 2016-17 upto 2018-19 (3 years).

2. Further, Ministry has approved allocation for number of minority trainees to be trained in the given traditional skill in the identified cluster of given Craft/Art by you under "USTTAD" during 2016-17 as follows:

3. The PIA shall immediately start mobilization of allocated number of minority youths willing to receive traditional skill trainings under the scheme who are eligible as per provisions of the scheme. It is advised that during mobilization, parents of the trainees may also be counseled. The mobilization should be completed within 45 days from the date of issue of this letter. Memorandum of Understanding (MoU) will be signed with you before release of 1st installment.

4. The organization shall focus on training of youth in identified clusters with the help of Master Craftsmen/Artisans. They shall also earmark minimum 33% for minority girls/women as per guidelines. Guidelines of the scheme are available on the website i.e. www.minorityaffairs.gov.in of the Ministry.

5. The course duration and curriculum would be as per para 5 (IV) of scheme guidelines. The inputs of Master craftsmen/artisans involved in training may also be taken. . The PIA will follow all terms and conditions mentioned in the scheme guidelines.

6. **The PIA will register itself on NGO Darpan Portal of NITI Aayog and provide the Unique ID number to the Ministry along with the Screenshot immediately. It is mandatory.**

7. Further, it is requested to furnish the state wise and centre wise list along with the name of traditional skill to be imparted to the trainees in the enclosed proforma and summary proforma.
